

BYLAW NO. 2022 – 05

Town of Rocanville

A BYLAW TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER.

The Council of the Town of Rocanville, in the Province of Saskatchewan, enacts as follows:

1. The charges to be paid by the water consumer, whose service is located within the corporate limits of the Town of Rocanville, whose water service has been turned on shall be those set out in Schedule “A” attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule “B” attached.
3. The charges to be paid by the water consumer:
 - a) whose service is located outside the corporate limits of the Town of Rocanville, whose water service has been turned on;
 - b) whose primary purpose is to haul potable water for agricultural/domestic use outside the corporate limits of the Town of Rocanville; or
 - c) who is obtaining potable water from a key-operated water outlet for commercial use

shall be those set out in Schedule “C” attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.

4. Accounts for water service and/or sewer service shall cover a period of three successive months, and shall be invoiced as early as possible in the months of February, May, August and November. Accounts shall be paid within the three month billing period, before another quarterly billing is rendered. If an account is not paid prior to the next billing, the water service may be discontinued or the amount in arrears may be added to the corresponding property tax account. When the water service is disconnected, it shall not be re-established until all arrears have been paid, together with a fee of \$50.00 to cover the expense of disconnected and reconnecting the utility service. If it is required to turn on the utility service outside the employees’ regular working hours, the reconnection fee shall be \$100.00.
5. Consumers will be eligible for a \$15 discount on current charges when paying during the month of invoicing (February, May, August and November) or when making prepayments.
6. A penalty of 10% will be added to all water and sewer accounts outstanding at the date of the next billing.
7. Bylaw No. 2015 – 09 of the Town of Rocanville is repealed.

The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee of the Saskatchewan Municipal Board.

Sewer Charges For Customers Located Within Town Limits

All sewer fees will be invoiced quarterly. The basic quarterly charge will be \$52.50. Customers exceeding consumption of 10,000 gallons per quarter will receive an additional charge of 85% of the water charges exceeding \$52.50.

Example: 14,000 gallons consumed per quarter = Water \$73.50
= Sewer \$70.35

5/8” and 3/4”	Domestic and Commercial	\$ 82.30	10,000 gallons	\$8.23
1”	Commercial	\$205.75	25,000 gallons	\$8.23
1.5”	Commercial	\$493.75	60,000 gallons	\$8.23
2”	Commercial and Rural Use	\$822.90	100,000 gallons	\$8.23

There are no consumers in Schedule “C” that receive sewer services from the Town of Rocanville; therefore, Schedule “B” does not apply to any of these customers.

Basic charges that vary, due to water meter size, are justified because the Town’s infrastructure was built to accommodate their potential requirements.
